#### **Overall Purpose of the Job**

To contribute to the implementation in North East Scotland of the Saving Scotland's Red Squirrels - Developing Community Action (SSRS-DCA) project:

- To protect red squirrels in Aberdeen and surrounding countryside from replacement by grey squirrels and work towards complete eradication of grey squirrels from the region.
- To detect squirrel presence and alert the project to the presence of grey squirrels, while monitoring the response of red squirrels to grey squirrel removal.
- To provide assistance to the Grey Squirrel Control staff in their grey squirrel trapping duties.

#### **Main Duties**

### **Surveying and Monitoring**

- Carry out Squirrel Presence/Absence Surveys twice a year in spring and autumn, using feeder-box hair-traps at permanent sites across Aberdeenshire according to the existing protocol. Responsible for maintenance and hygiene at feeder-boxes.
- 2. Assist recruitment of volunteers wherever possible to take over the running of the boxes and the hair sample collection.
- 3. Analysis of hair samples to identify species and collation of data into a standardised database
- 4. Maintain trail cameras in specified sites to assist in the detection of red and grey squirrels.
- 5. Identification of squirrel hair samples collected in the surveys and entering survey data into the SSRS spreadsheets.
- 6. Contribute to innovative approaches to survey and trapping methodologies.

# **Grey Squirrel Control**

- 7. Carry out grey squirrel control in areas outlined above in reaction to grey squirrel hairs being detected or images collected at a site.
- 8. Assist with grey squirrel control in and around Aberdeen as advised by the SSRS-DCA Conservation Officer North East, including delivering an on-call service on 1 weekend in 3 providing professional grey squirrel despatch for householders on the trap-loan scheme.
- 9. Produce risk assessments for all outdoor work and comply with SWT's lone working policy for personal and third party safety.

#### Reporting

10. Keep records of monitoring and trapping effort, location and results to agreed SSRS project standards and submit accurate records and timesheets monthly to the Conservation Officer North East. Data collection sheets will be provided by the SSRS project and should be submitted in Excel format. (Computer are provided, Excel training can be provided if required.)

- 11. Encourage interest in local red squirrel conservation with relevant local communities and encourage recording and reporting of squirrel sightings
- 12. Raise public awareness of, and involvement in, grey squirrel control for red squirrel conservation through the promotion of the Project's trap-loan scheme.
- 13. Assist the SSRS-DCA Conservation Officer North East to respond to enquiries from the public regarding grey squirrel control for red squirrel conservation.
- 14. Assist at occasional events to raise awareness with the public of the red squirrel conservation work of the project.
